Agreement to HOLD HARMLESS, WAIVER and ASSUMPTION of RISK

I, the undersigned, hereby acknowledge that I have voluntarily applied to participate in training activities or performance events offered by CHER CAR KENNELS. I acknowledge that there are risks involved in bringing my dog(s) into contact with other dogs, and in my participation in CHER CAR KENNELS classes, functions and events including the risk of my dog(s) contracting a communicable disease and the risk of physical injury arising from an altercation with another dog, the condition of the training premises and grounds, and a wide range of other factors. I also understand that participation in such programs is not without risk to myself, members of my family or guests who may attend, or my dog(s), because some of the dogs to which I will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care. While CHER CAR KENNELS may take steps to reduce those risks, I acknowledge that it cannot and does not guarantee that they will be eliminated. I state that both myself and my dog(s) and all members of my family or guests who take or attend these classes are both mentally and physically able to withstand the rigors of this training.

I hereby waive and release Cher Car Kennels LLC hereinafter referred to as the "Training Organization", its employees, officers, members, invitees, clients and agents from any and all liability of any nature, for injury or damage which I or my dog(s) may suffer, including specifically, but without limitation, any injury or damage resulting from any action of any dog, and I expressly assume the risk of such damage or injury while attending any training session, or any other function of the Cher Car Kennels LLC Training Organization, or while on the training grounds or the surrounding area thereto including, but not limited to, 4215 S. Lowell Road, 4219 S. Lowell Road, 4219 1/2 S. Lowell Road, 4235 S. Lowell Road and 4305 S. Lowell Road in Saint Johns, Michigan.

In consideration of and as inducement to the acceptance of my application for training activities or performance events offered by the Cher Car Kennels LLC Training Organization, I hereby agree to indemnify and hold harmless the Training Organization, its employees, officers, members, clients, guests and agents from any and all claims, lawsuits, demands, causes of action, liability, loss, damage and/or injury, of any kind whatsoever (including without limitation for monetary loss, property, damage equitable relief, personal injury or wrongful death), or claim made by any member of any family or any other person accompanying me to any training session or function of the Training Organization, or while on grounds or the surrounding area thereto as a result of any action by any dog, including my own.

I certify the accuracy of all information given about my dog(s) and specifically represent that I am the owner or co-owner and acknowledge sole responsibility for all acts or behavior of my dog(s). My dog(s) is up to date on vaccinations for Rabies, Distemper, Hepatitis, Leptospirosis, and Parvovirus. If taking protection class, I understand that the class is not for the purpose of attack work, but rather stresses situation aggression training. I understand that once my dog is exposed to protection training, he/she may be quicker to respond in any given situation, and that I must and WILL make provisions for this.
